## GLOSSARY OF SERVICES PROVIDED

---

**Adult Day Care** – a place for aged and disabled individuals with serious health problems or impairments to go during the day for recreational activities, personal care supervision, nutrition, limited health care and the opportunity to interact socially with other people in the group or individual activities.

**Case Management** – the mechanism by which services are coordinated and monitored to individuals at risk for institutionalization in an effort to provide continuity of care and avoid costly duplication of services.

**Elder Abuse/Neglect/Exploitation Prevention** – provides services for vulnerable adults who are being abused, neglected or exploited.

**Emergency Response System** – allows older persons to remain living independently at home with the capability of calling for help in emergency situation.

**Emergency Services** – social, financial and supportive assistance to help elderly individuals through a crisis, life-threatening or unexpected emergency situation which demand or requires immediate action or intervention.

**Homemaker Services** – supportive services provided in the home by a trained homemaker that involves education and/or provision of home management tasks in order to assist in strengthening family life, promoting self-sufficiency and enhancing quality of life.

**Legal Assistance** – assist older persons to identify possible legal problems and in the legal process to resolve problems while preserving their legal rights and entitlement.

**Long-Term Care Ombudsman Program** – serves residents of Mississippi in nursing facilities and personal care homes, and is the only program that provides an outside presence regularly in many of the facilities.

**Long-Term Care Alternatives Program** – provides information, education, and referrals to Medicaid applicants on alternatives to nursing home facilities.

**Congregate Meals** – provides a meal to an eligible person in a group setting.

**Home Delivered Meals** – meal provided to an eligible person in his/her home.

**Mississippi Insurance Counseling and Assistance Program** – a counseling program designed to answer elderly and disabled citizen's questions about health insurance (Medicare, Medicaid, Medicare Supplement and Long-Term Care Insurance, and HMOs).

Three Rivers Planning & Development District (Glossary of Services - cont.)

**Neighborhood Service Centers Sponsored by Lift Inc.** – designed to provide an array of services to the Community in an eight county area. Namely: Calhoun, Chickasaw, Itawamba, Lafayette, Lee, Monroe, Pontotoc and Union. Applicants must meet an income guideline.

**Ryan White Program** – copy formulary along with all necessary forms to enroll an HIV/Aids patient in the Ryan White Care Aids Drug Assistance Program (ADAP) – Mississippi State Department of Health – Division of STD/HIV.

**Mid-Delta** – holistic approach address the well-being of each of our patients regarding their physical, mental, social and spiritual needs.

**Senior Community Service Employment Program Title V** – designed to provide, foster, and promote useful part-time opportunities in community services employment for low-income persons who are 55 years of age or older and, to the extent feasible, to assist and promote the transition of program enrollees to private or unsubsidized employment.

**Transportation** – the travel of eligible older individuals to and from community resources for the purpose of obtaining needed services or goods.

**New Saltillo Firm** – Elderly & Disabled Services of Mississippi Inc. will provide non-medical care in the home.
