

Assisted Living Waiver

Home and Community-Based Services



What is the Assisted Living Waiver?

The Assisted Living Waiver is a statewide program designed to offer assistance to qualified Medicaid beneficiaries. This program allows qualified individuals to reside in an Assisted Living Facility with Medicaid paying for the services received in the facility. The program allows qualified individuals to remain in a home or community-based setting as an alternative to nursing facility care or other institutional care. Participants are re-certified annually the need for continuation in the waiver.

The facility must be licensed by the Mississippi State Department of Health as Personal Care Home-Assisted Living.

Who is qualified?

- Beneficiaries must be 21 years of age or older.
- Persons qualify by either SSI or 300% of SSI.
- Beneficiaries must score 50 or above on the Medicaid Long Term Care Pre-Admission Screening (PAS) instrument.
- Persons must require nursing facility level of care, if assistance is not provided.

What services are offered under this waiver?

Beneficiaries enrolled in this waiver program must contribute to the facility for their own room and board. Medicaid will pay the facility a daily flat fee for services received in the facility.
